Documents and Procedures – Nicki Phillips

- Continually updating, such as liaison timeline
- Make more current, more helpful to the Long Distance Committee
- Host Bid form is very long, especially for an event that recently hosted. Make things easier for hosts to complete.

Old Business – Continue to work on the 2024 goals:

1. Develop a plan to increase the number of overall USMS sanctioned open water events
2. Look for more prominent venues for Open water National championships
 - Clarify Open water strategy between LDC and NO
 - 1-3mi OWNC weekend festival concept already in discussion
 - Clarify NO role regarding the OWNC bid process, at least for shorter events.

3. Remove the operations and procedures (Part III) from USMS Rule Book and move to Guide to Operations documents. If it is not a hard and fast rule that is not subject to be followed always should be moved from the USMS Rule Book to the Guide to Operations documents.

New Business: Rules – Jim Davidson

- Protest: revised the responsibility for who the protest should be made to (onsite the referee or event director). Cannot be appealed.
- Who is responsible for appeals to virtual swims? LDC Chair, who has final determination (7 days to reply)
- Protests regarding gender: be addressed to the rules committee.
