## RECORDS AND TABULATION COMMITTEE REPORT

The committee reviewed the status of the TOP10 tabulations for each of the three courses. The committee discussed what type of "errors" should be included in an errata and established the following TOP10 policy.

ERRATA will contain corrections for:

errors made by the National TOP10 Recorder errors made by the LMSC TOP10 Recorder submissions lost in transit.

The errata will not be used for results entered late.

The committee reviewed the new WORLD RECORD requirements:

- . all documentation must be received by World Recorder within 6 months of swim.
- a copy of the swimmer's birth certificate or passport is required.
- . a pool measurement document is required.

The committee reviewed the progress on a computer interface between the LMSC TOP10 and the National TOP10. Currently 10 LMSC are using disks to transfer the TOP10. This will continue to be a high priority effort next year.
